RESOLUTION NO. 20-1117

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLVANG, CALIFORNIA, CALLING FOR THE HOLDING OF A GENERAL MUNICIPAL ELECTION ON TUESDAY, NOVEMBER 3, 2020, FOR SUBMISSION OF THE QUESTION OF THE RECALL OF NIELS CHRIS DJERNAES AND THE ELECTION OF A CANDIDATE TO FILL THE VACANCY IF THE RECALL PREVAILS

WHEREAS, under the provisions of the law relating to cities in the State of California, recall petitions were filed demanding the recall of Niels Chris Djernaes, Council Member; and

WHEREAS, the petitions were signed by more than 25 per cent of the voters of the City of Solvang; and

WHEREAS, the City Council is authorized and directed by statute to submit the proposed recall to the voters; and

WHEREAS, a candidate shall be elected to fill the vacancy if the recall prevails.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SOLVANG, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That pursuant to the requirements of the City of Solvang Charter, there is called and ordered to be held in the City of Solvang, California, on Tuesday, November 3, 2020, a General Municipal Election for the purpose of submitting the question of the recall of Niels Chris Djernaes, Council Member, and the election of a candidate to fill the vacancy, if the recall prevails.

SECTION 2. That on the ballots to be used at the election, in addition to any other matters required by law, there shall be printed substantially the following:

Shall Niels Chris Djernaes be recalled (removed) from the office of City of Solvang Council Member?	YES
office of City of Solvaring Council Member :	NO
For City of Solvang Councilmember	
To succeed Niels Chris Djernaes if he is recalled.	Vote for ONE
Term Ending December 2022	
(Followed by the list of candidates qualifying for this office)	

(Note: List of Candidates to be presented following close of the nomination period August 20, 2020)

SECTION 3. That the ballots to be used at the election shall be in form and content as required by law.

SECTION 4. That the City Clerk is authorized, instructed and directed to procure and furnish any and all official ballots, notices, printed matter and all supplies, equipment and paraphernalia that may be necessary in order to properly and lawfully conduct the election.

SECTION 5. That the polls shall be open at 7:00 o'clock a.m. of the day of the election and shall remain open continuously from that time until 8:00 o'clock p.m. of the same day when the polls shall be closed, pursuant to Elections Code Section 10242, except as provided in Section 14401 of the Elections Code of the State of California.

SECTION 6. That in all particulars not recited in this resolution, the election shall be held and conducted as provided by law for holding municipal elections.

SECTION 7. That notice of the time and place of holding the election is given and the City Clerk is authorized, instructed and directed to give further or additional notice of the election, in time, from and manner as required by law.

SECTION 8. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
